## **Corporate Social Responsibility**

As expressed in their mission statement, Schjødt wishes to contribute to the evolution and development of a broader society, primarily by influencing legislation and its interpretation, taking part in ground-breaking litigation and advising governmental and private clients on matters of major importance to Scandinavian and UK businesses, but also by performing pro bono work, seeking to prevent or correct injustice and contributing to selected community or charitable services.

The pro bono program involves taking on matters on a non-commercial basis and collaborating with charitable organisations, cultural institutions, and other non-profit entities. Reportedly, Schjødt partners and lawyers take pride in providing this pro bono counselling. The firm dedicates significant resources to pro bono work each year and has established guidelines for selecting and handling pro bono cases.

In recent years, Schjødt has prioritised cases involving freedom of speech and human rights. The firm also actively participates in a program that provides free legal advice and representation to refugees and immigrants who have received deportation notices. In several instances, Schjødt's efforts have reversed the expulsion rulings,

including successful appeals to prior court judgments.
